ARTICLES OF INCORPORATION

of

COLORADO SECTION OF THE SOCIETY FOR RANGE MANAGEMENT

The undersigned persons acting as incorporators of a corporation under the Colorado Nonprofit Corporation Act, sign, and, acknowledge the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Colorado Section of the Society for Range Management.

SECOND: The period of duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized shall be to seek a comprehensive understanding of range ecosystems and of the management and use of range resources; to assist all who work with rangeland to keep alreast of new findings; to improve the effectiveness of range management in obtaining from range ecosystems the products and values necessary for man's welfare; to create a public appreciation of the social and economic benefits to be derived from range resources; and to promote the professional development of its members.

FOURTH: The address of the initial registered office of the corporation in Colorado is 2120 South Birch Street, Denver, Colorado 80222 (City and County of Denver), and the name of its initial registered agent at such address is Francis T. Colbert.
